• On Art. 13 para. 1 c):

The collection of personal data is required because the data of the cash-free payment transactions with the electronic purse are stored by the acceptance points and transmitted to the Studentenwerk for billing. This is based on your consent in accordance with. Article 6 para. 1 (a) GDPR. (Legal basis)

• On Art. 13 para. 1 e):

The personal data will be processed further and transmitted to other competent bodies as follows:

Departments and Staff Units:

- Accounting: Use of personal data for all payments resulting from the AutoLoad/ guest card/ MensaKidsCard procedure. Payment transactions with the electronic purse are stored by the Acceptance Centres and transmitted to the Studentenwerk for billing purposes. The processing of the billing data is done anonymously by storing the serial number of the card, the cancellation or revaluation amount and the card balance. When participating in the direct debit procedure, the bank details of the EC Maestro card used are also stored.
- o Information technology (IT department): Use of personal data from the operation of the infrastructure required for data processing.

• On Art. 13 para. 2 a)
